(Fees are subject to change without notice; please contact CFA for current fees.)

### Mediation Services

### Fee Explanations

#### Home Study Fee

Home study fees vary due to the number of interviews and different requirements for each.

**Infant** - Our agency can provide this service to families in Oregon and Washington. **This fee is due when service is requested.**

Families outside Oregon and Washington will need to contract with a local licensed agency and send us a copy of the home study.

**Special Needs** - **This fee is due when service is requested.** When placement finalizes the state will reimburse your home study fee and other fees up to \$1,500 for Oregon.

**Independent** - **This fee is due when service is requested.**

**International**- **This fee is due when service is requested.**

#### Unusual Expenses

This fee is for excessive and unusual legal, medical or other charges. **This fee is due when billed.**

#### Post Placement Supervision

**Infant** - Post placement supervision is required after a child is placed in your home. Our agency requires a minimum of two post placement supervision visits for our infant placements. Post placement is usually contracted through the same agency that did your home study. Should concerns be encountered, additional visits may be necessary. **This fee is due at the time of the first visit.**

**Special Needs** - Post placement supervision is required after a child is placed in your home. For Special Needs adoptions, supervision lasts 6 - 12 months. **The state pays this fee.**

**Independent** - Post placement supervision for an independent adoption includes a supervision visit and a report for the court, which is contracted by DHS.

**International** - Your placing agency will determine post placement supervision requirements. We charge \$350 per visit/report.

#### Mileage

Adoptive families will be charged for mileage to and from their homes when a social worker visits. This is based on the current IRS rate. **This fee is due at the time of the visit.**

#### Home Study Review

If you have an out of state home study from another agency, we will review it to ensure it contains all the components the State of Oregon requires.

### Refund Policy

#### Application Fee

*Nonrefundable*

#### Home Study Fees

*90% refundable before attendance of the social worker's first visit. After first visit refund for fees are at the discretion of the Executive Director.*

#### Post Placement fees

*Refundable until social worker's visit.*

#### Domestic Program Fees: SNAC, Loving Options, Mediation, AAI

*60% Refundable if family withdraws 4 weeks or less after contract signed*

*40% Refundable if family withdraws 4-8 weeks after contract signed*

*No refund will be issued after 8 weeks*

REFUND NOTE: If a family fails to properly disclose information or in any way puts the agency and its interests at risk, Christian Family Adoptions retains the right to terminate adoption process without providing any refund. If there are special circumstances that require a family to withdraw temporarily or suspend their adoption, Christian Family Adoptions will apply 80% of the previously paid fees to the reactivated adoption if it takes place within eighteen months of the withdrawal/suspension. If more than twelve months have elapsed the family will need to reapply and all fees due the agency will be at the then current rates. The Executive Director retains the right to assess individual cases and determine refunds for atypical cases.
